1 INTRODUCTION

Our practice with respect to use your personal information is as set forth below in this privacy policy.

2 WHAT WE NEED



Whilst the majority of the personal data you provide to the company is mandatory, some is provided on a voluntary basis. When collecting data, the company will inform you whether you are required to provide this data or if your consent is needed. Where consent is required, the school will provide you with specific and

explicit information with regards to the reasons the data is being collected and how the data will be used.

The categories of child information that the company collects, holds and shares includes, but is not restricted to:

- Relevant medical information

3 WHY WE NEED IT



St Matthews Children's Action Group collects and uses personal data relating to children and their families, and we may also receive information regarding them from their school, LA and/or the DfE. We collect and use personal data in order to meet legal requirements and legitimate interests set out in the GDPR and UK law, including those in relation to the following:

- Article 6 and Article 9 of the GDPR
